PERMISSION TO PARTICIPATE IN CHURCH ACTIVITIES AND RELEASE AGREEMENT

DEFINITIONS: Agent(s) as stated herein are the church, pastor, assistants, staff, officers, activity director, sponsor(s), bus, van or auto drivers or any person(s) directed by the church to supervise or assist in the supervision of any activity.

WHEREAS Orcutt Baptist Church, Newport News, Virginia and its agents hereinafter referred to as the "Church" has agreed to work with the child/children/adults or parents or guardians hereinafter referred to as "Parents" or "Guardians" and

WHEREAS the parties hereto have reached an agreement concerning the activities of said children or adults,

NOW THEREFORE in consideration of the mutual promises and obligations stated herein, it is agreed as follows:

1. This agreement is to cover all activities which may be under the direction of the agent(s) selected by Orcutt Baptist Church, said agreement to be effective on **January 19, 2004 only** for (Student) _____.
2. If in case of an accident or mishap involving a child/children/adult connected with the parent or guardian, it is understood that while the person is traveling to, participating in and returning from any activity, such action is at his/her own risk. The church or its agents are not responsible; even though reasonable precautions will be taken to secure the safety of your child/children/adult while at the place of activity.
3. The agent(s) provided by the church hereby have the permission of the parents or guardian to instruct the child/children/adult while he/she/they are participating in the activities. If the child/children/adult will not follow instructions or becomes uncontrollable, the parents will be notified and the person sent home. List any activities in which your child/children/adult should not participate:

4. If the parent/guardian's child/children/adult should become seriously ill, the agent(s) will make a reasonable effort to notify one of the parents/guardians in order to obtain instructions as to the treatment of the child/children/adult. If one of the parents/guardians cannot be reached, the agent(s) are hereby given authority to use their own reasonable discretion in the treatment of the person for illnesses of a mild nature. In case of sickness or illness requiring emergency treatment and/or surgery, the agent(s) are hereby given authority to secure that treatment immediately from a doctor, hospital and/or other medical personnel of the agent(s) choice. One of the parents/guardians shall be notified as soon thereafter as possible.
